A **Professional Member** shall be required to be a person who is an engineer or scientist or other with professional responsibilities in the field of coil winding or electrical manufacturing, with not less than two years of professional participation in research, development, application or sales. An engineer, scientist or other is defined as a person who has been granted a degree of Bachelor level and/or a person who has been gainfully employed for not less than five years in performance of duties that pertain to scientific, engineering or sales.

**Please Enroll me as a Professional Member.** Yearly dues are \$50.00 in U.S. funds for members with address in Canada, Mexico and the United States. In all other countries, the annual dues are \$75.00. The difference in membership fees is because of increased postal charges outside of Canada, Mexico or the United States.

**Please Enroll me as a Associate Member.** Yearly dues are \$50.00 in U.S. funds for members with address in Canada, Mexico and the United States. In all other countries, the annual dues are \$75.00. The difference in membership fees is because of increased postal charges outside of Canada, Mexico or the United States.
